- 3. that the admission in the institution shall be made strictly in accordance with the norms as laid down by the Board of School Education to which the school is affiliated and no discrimination on the basis of caste, co lour, creed and sex shall be made. No pupil shall be refused admission on account of his caste creed or religion.
- 4. that the private institution shall employ only the trained/eligible staff as per the norms fixed by the Govt.
- 5. that no particular religious education shall be imparted by the institution to maintain secular character of the institution.
- 6. that the fees and funds shall be such that they are not of exploiting nature but contribute to the spread of education. They should be commensurate to the salary of the staff being paid, development of infrastructure and facilities and activities being provided to the students.
- 7. that the permission to run or establish a private educational institution shall be granted only on individual basis and the institution shall not be entitled to open its branches elsewhere.
- that the institution shall maintain proper record of receipts and expenditure and shall submit within six months at the end of the academic year and the report of audit conducted by the Chartered Accountant to the competent authority.
