ANTI-DRUG AWARENESS ESCAPE ROOM GAME FOR POLICE DAV PUBLIC SCHOOL, AMBALA

1. Introduction: Police DAV Public School, Ambala, invites bids under a two-bid system for the development and construction of an Anti-Drug Awareness Escape Room Game for school children called Chakravyuh. The primary objective is to create an educational and interactive experience for school children to raise awareness about the harmful effects of drug abuse. While traditionally a source of entertainment, escape rooms inherently hone skills of problem-solving, collaboration and lateral thinking. By adapting these rooms to mirror the very challenges – like drug, delinquency and distraction enticements, harnessing personal aptitudes and the importance of communication – the teens can experience the consequences of their actions and decisions in a controlled space.

2. Scope of Work: The scope of work encompasses the following:

Bidder's Technical Proposal (Bid A):

- a. Design and construction of the anti-drug escape room.
- b. Development and integration of educational content.
- c. Installation of puzzles, challenges, and props.
- d. Incorporation of audio-visual elements for enhanced learning.
- e. Construction of a control room for monitoring and guidance.
- f. Ensuring safety, security, and compliance with building codes.
- g. Any other technical and design-related aspects.

Bidder's Financial Proposal (Bid B):

- a. Cost breakdown for the entire project.
- b. Cost allocation for construction, equipment, and maintenance.
- c. Any additional expenses, if applicable.
- d. A detailed financial plan for the project.

3. Eligibility Criteria: Interested bidders must meet the following criteria:

5. Evaluation Criteria: The evaluation of bids will be carried out in the following manner:

Technical Proposal (Bid A) will be evaluated based on design, educational content, safety measures, and compliance with standards. The escape room should be a blend of traditional puzzles coupled with modern technology, like Augmented Reality (AR) clues and immersive

Virtual Reality (VR) scenarios. This balance ensures that the challenges are engaging, have a touch of the 'wow' factor, yet are not so daunting as to deter participation.

Financial Proposal (Bid B) will be evaluated for cost-effectiveness and value for money.

6. Contract Award: The contract will be awarded based on a combination of the Technical and Financial Proposals. Police DAV Public School, Ambala, reserves the right to accept or reject any or all bids without providing any reasons.
