- 1. First step is by filling up the Parent's PTA Nomination Form on E-learning portal.
- 2. In the nomination form kindly fill in the mode of participation whether it is through personal interaction or through telephonic interaction.
- 3. Personal interaction will be done in the school on Saturday 6th July, 2019. Slot I- 9.00 Am. to 11.00 a.m. For Nursery to Grade V Slot 2 - 12.00 noon to 2.00 p.m. For Grade VI to Grade XII
- 4. 10 min telephonic conversation will be conducted for those desirous of getting elected through telephonic mode on Saturday, 6th July, 2019 Slot I- 8.30 a.m. to 10.30 a.m. For Nursery to Grade V Slot 2 - 11.00 a.m. to 1.00 p.m. For Grade VI to Grade XII
- 5. A five ex- member team will be involved in electing the new PTA members.
- 6. Ex-PTA members of last 3 years may not be able to offer their candidature.
- 7. The nomination form at the DAV e- learning site will be available from 1st July to 4th July 2019 till 4.00 p.m.,. Open the portal at <u>http://davahmedabadelearning.online</u> Click on general information. Click on the PTA form and fill it.

All the parents are requested to either fill in the form or send their consent through almanac by 4th July, 2019.
