RULES AND REGULATIONS FOR AVAILING SCHOOL TRANSPORT

- 1. No student is allowed to discontinue the bus facility in the mid of the session.
- The parents are required to deposit the transport fees regularly.[1st quarter (April to June),& 4th Quarter(January to March).For the months from July to December, parents can make the payment monthly/quarterly basis]
- 3. The student who wants to discontinue the transport facility in the mid of the session must clear the 12 months transport fee.
- 4. The student who wants to avail the school transport in the mid of the session must pay for the entire session.
- 5. In general, the enrolled students are required to pay Transport Fee for the entire session, irrespective of holiday and vacations.
- 6. The school reserves the right to increase Transport fees on price hike of vehicle consumables.
- 7. The school reserves the right to fix up the boarding points of bus routes.
- 8. Change of boarding point by any student is allowed only with prior permission of the Transport Manager.
- 9. Only the enrolled students with valid Bus passes are permitted to travel in the school bus.
- 10. The students are expected to maintain utmost discipline inside the bus while travelling.
- 11. The students must reach their Boarding Point 10 minutes before the notified time.
- 12. The students must behave properly with the Bus Staff and follow the instructions given time to time.
- 13. The Senior students should offer seats to their juniors during travel.
- 14. While boarding / getting down, the students must not run beside the bus.
