8. Tenders are to be submitted on the printed forms uploaded in the website. The contractors should quote the rates in figures as well as in words. The amount of each item shall be worked out and the requisite total shall be given. All corrections shall be attested by the initials of the tenderer. In case of any discrepancy/difference, the rate quoted in words in the original copy of tender and the amount derived there from shall prevail and shall be binding. The notes quoted by the agency shall be including GST.

9. Tender, duly filled, will have to be submitted in two parts, PART- A and PART- B separately superscribed sealed and both contained in another sealed envelope, superscribed with the name of the work.

PART- A shall contain all technical, financial and general stipulations proposed by the contractor along with covering letter and EMD.

PART- B shall contain the offered price along with the tendered documents duly filled.

10. The acceptance of the tender will be made by the owner who does not bind himself to accept the lowest or any other tender or part thereof. No reason will be furnished for acceptance and rejection of the tenderer whatsoever.

ELIGIBILITY CRITERIA :-
