7. That the school shall strictly abide by the provisions of the Delhi School Education Act & Rules of 1973.

8. That the enrolment in each section shall not exceed the number of students for the available floor area of the class-room and the school shall provide adequate and sufficient accommodation as per norms of the Directorate of Education, Delhi each class. Number of the existing sections should not exceed the number of class-rooms of proper size in the school.
9. That the school shall not run any pre-primary and unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place. Nursery classes be removed from the premises of the school, if any. No branch of this school shall be run under the banner of the recognised school. No separate school in the second shift shall be started & if notice recognition shall be withdrawn.
10. That all the Middle ( I-VIII ) classes may be shifted from Janakpuri to Vikaspuri.
11. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately.
12. That service contract between the management and the employees shall be executed immediately.
13. That all the facilities prescribed under Rule 50 and 51 of DSER, 1973 shall be made available to the students & provisions of Rules 6, 7 and 9 be strictly observed.
14. That the arrangement for good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the student adequately. Health certificate may be obtained from the local body within a month.
15. That the management of the school create a serve fund of Rs.5000/- (Rupees Five thousand only) in a joint account in the name of the Director of Education and the Manager of the school in any scheduled bank within a month.

7. That the school shall strictly abide by the provisions of section 10(i) of the Delhi School Education Act and Rules, 1973, and payment shall be made through crossed cheques.
8. That the enrolment of each section shall not exceed the number of students calculated @ 12 sq. ft. per student for the available floor area of the class-room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education in each class. Number of class-rooms should not exceed the number of existing class-rooms of proper size in the school and each class-room, science lab. and library rooms may be fitted with proper electrical appliances.
9. That the school shall not run any un-recognised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the above address only. Un-recognised classes be removed from the premises of the school immediately. That the school shall obtain the Fresh Health Certificate from the M.C.D.

18. That the school shall shift its all classes from 1st to 12th to the new site and after the construction of a suitable building therein, with the prior approval of the Director of Education, the present school will be closed thereafter forthwith.
