The revised fee structure, after effecting 14% hike as permitted by DOE, is attached herewith and the same is effective from 1st October 2022. Revised fees shall be levied from March 2023 onwards. Arrears are payable for five months from October 2022 to February 2023.

Please note that monthly fee is to be paid as per the normal fee-paying schedule. For the convenience of the parents it is decided to charge the five months fee arrears in two installments. First installment will be payable in the month of March 2023 and Second installment will be payable in the month of June 2023 (except for the outgoing students of class XII). Refundable Security of eligible students have been adjusted in the fee for the month of February 2023.

We would like to express our gratitude for your support and cooperation to the VVDAV family. We are thankful for your trust in our prestigious institution and timely payment of the school fees. Looking forward to your continued support.
