## **Dear Parents**

Veda Vyasa D.A.V Public School, Vikaspuri is committed in providing quality and holistic education to nurture its young learners and the best educational infrastructure.

In pursuance of the directions issued by the Directorate of Education, the school did not hike fees in the academic session 2016-2017. The school continued with the last fee structure of the session 2015-16, adjusting the enhanced fee, collected from the parents during the session 2016-2017. A proposal for the fee hike was submitted to the Directorate of Education and the Directorate has allowed the school to increase the existing fee by 5% for the session 2016-2017 vide its Order dated 04-10-2017. In compliance of the order, the tuition fee has been revised w.e.f. 01-04-2016 as follows:

For the convenience of the parents, the school will collect the fees on monthly basis from December, 2017 to March, 2018.

It may also kindly be noted that as per the directions given by the Directorate of Education vide its Order No. DE.15(318)/PSB/2016/19786 dated 17.10.2017, the School Management has to implement the 7<sup>th</sup> Central Pay Commission recommendations. In this regard, the revised fees, within the prescribed limit, for the session 2017-2018, will be informed after due procedure.
