## (ELIGIBILITY CRITERIA, FOR CBT 2025)

- 1. Graduate/Post Graduate with minimum 50% marks as aggregate, Computer knowledge is desirable for all posts.
- B.Ed. is mandatory for all teaching posts. For NTT (2 years NTT Diploma from Recognised University/ Institution), B.PEd./M.PEd for Physical Education Teacher; Degree in Fine Arts and Music; B.Lib./M.Lib. for Librarian.
- 3. CTET/STET is required as per CBSE norms for all teaching posts. For PGT candidate having minimum 03 to 05 years teaching experience of Sr. Secondary classes is required & CTET / STET is desirable.
- 4. Fluency in English speaking is basic requirement.
- 5. In Sanskrit, Hindi, Physical Education, Music, Fine Arts, Library Science. & S.St. (Group) only PRT/TGT is required.
- Candidate appearing for LDC, UDC & Assistant should be Graduate with Computer proficiency, Tally, Noting & Drafting. Minimum experience required for UDC-08 years as LDC; for Assistant- 10 years as UDC, subject to attach the Experience certificate with application forms.
- 7. Age must be below 35 years as on 31/12/2024. 40 years if a candidate having minimum 05(five) years teaching experience of CBSE affiliated school, copy to be attached with application forms. Age criteria for the candidates working in DAV Public School will be as per the norms of DAV CMC, New Delhi.
- 8. **CBT- 2025 will be conducted in three phases.**

Phase-1 : Scrutiny of Career Graph/Eligibility and selection of eligible candidates for CBT.

For this phase candidates may collect Application Form from any nearest DAV Public School in Bihar OR Download from any DAV Zonal website.

Duly filled up Application Form alongwith needed documents must be submitted to any nearest DAV School in Bihar OR may be sent by registered/ speed post to any nearest DAV School in Bihar.

## Phase- 2 : Conduct of Computer Based Test(CBT)

The eligible candidates after scrutiny of Application Form will be informed for online registration alongwith requisite fee through Recruitment website of DAV CMC New Delhi - https://davrecruit.davcmc.in. Keep visiting this website for further updates. DAV CBT 2025 qualified candidates will be issued Provisional Eligibility Card (PEC) by DAV CMC. With this PEC Candidates may apply at any DAV Schools across the country wherever the vacancy exists.

Phase- 3: Demo, Interview and Selection of the candidates by the selection committee at Zonal Level.

- 9. No candidate will be allowed to appear in the CBT from the school (Exam Centre) where he/she or his/her spouse or relative is/are working.
- 10. Non-CBT Adhoc/temporary/ Guest Faculty candidates must appear in CBT 2025.
- 11. Regular staff members aspiring for up-gradation to a higher post/designation (if there is a vacancy in the school), must appear in CBT 2025.
- 12. **IMPORTANT** : CBT qualified candidate, who has got employment at a DAV school by virtue of CBT 2024, need not appear in CBT 2025, **ONLY** if he/she continues to work in the same school at the same post. However, for joining another DAV school, in the same/other state/city, the candidate will have to appear in CBT 2025.
- 13. **IMPORTANT** : The candidates must use their RMN (Registered Mobile Number) and their own email id to login and fill the CBT Registration Form. The same mobile number & email id will be required to access the admit card or P.E.C. in the later stages. Hence, candidates are warned not to change their mobile number or use someone else's mobile number for registration.
- 14. Duplicate applications will not be accepted for CBT 2025. Each candidate must apply for ONE POST ONLY. The datesheet will be condensed and multiple exams will fall on a particular day/slot. Hence, candidates must apply for the post they are eligible for and confident about.
- 15. DAV-CBT will be conducted for all the posts collectively. However, different DAV schools of the zone/state may have vacancies for different posts as per requirement.
- 16. Final Selection will be made on the basis of Demo & Panel Interview at School / Zonal Level.

17. Services are liable to be transferred to any of the DAV Public Schools as per DAVCMC Norms.
