 - d.Inclusion of students with disabilities / special need as per provision of the RTE Act 2009 (rule/clause of State Act).
 - e. The teachers are recruited with minimum qualifications as laid under RTE Act 2009 (rule/ clause of the state Act).
 - f. The teachers perform his duties specified under RTE Act 2009(rule/ clause of the state Act).
