- The school shall submit their information through Online Affiliated School Information

- The optimum Section teacher ratio of 1:1.5 as well as student teacher ratio of 30:1 is to be 13. maintained to teach various subjects and school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.
- Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards
- Class X and Class XII examinations from the year mentioned while granting affiliation/upgradation regularly without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates.
- Running of coaching institutions in the school premises in the pretext of providing coaching to the students for various examinations is not permitted by the Board. Strict action would be

- 21. the Show Cause Notice was communicated or grievance / legal cases are pending against the school, the Board will take appropriate decision in this matter
 - The school shall renew all mandatory safety certificate i.e Safe Drinking Water & Health and
- 22. Hygiene certificate, Fire Safety Certificate and Building Safety Certificate from concerned Govt authorities time to time
 - The school shall also maintain record of certificate, compliances, data and other records/information and shall be fully responsible to produce all such records before Board
- and appropriate Government Authorities when asked for, failing which necessary action shall be taken as per Affiliation-Bye-Laws of the Board. The school shall also be liable for action by the appropriate Govt., in case of violation / non-compliance of the concerned Govt. norms
