- (7) The responsibility of all old names/places shall be accepted by the school and the change of new name of the school in the current papers shall be announced in the main newspapers and the office thereof shall be notified.
- (8) The District Primary Education Officer has verified the veracity of the grounds submitted as per the check list, so that if any question arises in the future, the immediate responsibility of the concerned District Primary Education Officer shall lie.
