In case of a student migrating from one CBSE affiliated school to another CBSE affiliated school the transfer certificate of a previous school of such a student may be countersigned by the Regional Officer of the Board or Asstt Commissioner of the KVS or the Deputy Director, Navodaya Vidyalaya Samiti in India or an officer of the Board at the Head Quarters and by the First Secretary/Attach/Cultural Attach or an equivalent office of the Embassy/High Commission of India in the concerned countery in respect of students studying in an affiliated school of the CBSE situated outside the countery and the student shall not be admitted to a school without such a counter signature Asstt. Commissioners, KVS have also been authorized to countersign the Transfer Certificate Issued by the schools run by Directorate General, Border Security Force.
